"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer and the City Auditor, both of Ormoc City; the Division Superintendent of Schools, Tacloban; and the District Supervisor, Ormoc I District, Ormoc City. "CARRIED, Unanimously."
