RESOLUTION NO. 190

"WHEREAS, the Presiding Officer, His Honor, City Mayor Esteban C. Conejos, informed this Body that the school authorities running the Provincial Meet have requested that hollow blocks be provided for the borders of the race track, to constitute as an additional improvement of the Ormoc City Central School athletic grounds preparatory to the holding of the Provincial Meet on December 2-6, 1958;

"WHEREAS, according to Mr. Roberto B. Paz, District Supervisor of Ormoc District I who is also an official of the meet, they need about P400.00 to buy 1,600 hollow blocks at P25.00 per hundred in order to complete the project; and

"WHEREAS, this Body sees the urgency of the request in view of the very limited time left to plant these borders along the track;


"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Penserga;

"RESOLVED, as it is hereby resolved, to appropriate the sum of P400.00 from out of the salary savings of any and all departments of the city government, to be made available for the purchase of 1,600 hollow blocks to be used for the improvement of the city central school athletic grounds preparatory to the holding of the Provincial Meet;


