RESOLUTION NO. 196

"WHEREAS, the Honorable City Mayor has brought up before the Board a request from the school teachers of Valencia regarding the fencing of the surroundings or yards of every house in the barrio;

"WHEREAS, this Board has known and heard much about the campaign of the Bureau of Public Schools for community improvement and has seen for itself the vigorous improvements of the municipality of Albura which has earned for the said municipality the distinction of being the model municipality throughout the country;

"WHEREAS, this Board believes that if only the campaign will be carried out vigorously by obliging every house owner to fence his surroundings, there is no reason why Ormoc City can not be as successful as Albura in community improvement;


"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved to request the Barrio Lieutenants of Ormoc City to require all inhabitants or house owners in their respective barrios to fence their yards or surroundings in order to forestall the possibility of the spread of infectious diseases carried by animals and another simple reason, to beautify their communities;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Barrio Lieutenants of Ormoc City; the District Supervisors of Ormoc I & II; and the PTA Presidents, all of Ormoc City.

"CARRIED, Unanimously."


