RESOLUTION NO. 1958

"WHEREAS, the Chief of Police, this City, in a letter to this Board dated December 6, 1958, requested that necessary representations be undertaken in behalf of the Police Department for the retention of the firearms loaned by the PC to the said department until such time as the City may be able to purchase the firearms needed by the Police Department;

"WHEREAS, in requesting for the retention of the aforesaid firearms the Chief of Police advanced the following reasons:

- (a) That some members of the Ormoc City Police Department are presently without firearms;
- (b) That commission of crimes often times happen without any previous notice, hence the necessity of firearms for the use of the members during the performance of their official duties;
- (c) That firearms mentioned above are presently used by the members of the department while on patrol duty in remote barrios and specially during the pursuit of hardened criminals;


"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to request the Chief of the Constabulary, Camp Crame, Quezon City, thru the PC Provincial Commander of Leyte, Tacloban, to defer the return of the aforesaid firearms loaned the Ormoc City Police Department, until such time as the city may be able to purchase the necessary arms;



"CARRIED, Unanimously."


