RESOLUTION NO. 206

"WHEREAS, during this session the City Engineer was called to appear before this Board to give information as to the status of the proposed Cogon Combado-Sto. Niño road;

"WHEREAS, the City Engineer informed this Board that the construction of the proposed road should have been undertaken had the owners of the lands along the proposed route signed the road right-of-way agreement; and

"WHEREAS, according to the City Engineer, despite the representations made by his Office, the land owners, one of them Mr. Filomano Torres, refused to sign the road right-of-way agreement, whereby, the City Engineer stated further, there would be no other recourse for the city to proceed with the construction of the proposed road, than to institute expropriation proceedings against said land owners;

"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Ocubillo;


"RESOLVED, as it is hereby resolved, to request the City Attorney, Ormoc City, to take steps for the expropriation proceedings against Mr. Torres and the other land owners affected by the proposed route of the Cogon Combado-Sto. Niño road, as per recommendation of the City Engineer;

"RESOLVED FINALLY, to furnish copies of this resolution each to the City Attorney, the City Engineer, the City Treasurer and the City Auditor, all of Ormoc City.

"CARRIED, Unanimously."


