RESOLUTION NO. 257

"RESOLVED, as it is hereby resolved, to amend Resolution No. 240, s. 1957 of this Board, so that instead of Councilor Guillermo T. Parrilla to accompany the City Mayor to Manila for the purpose aforesaid, it should be Councilor Alvaro I. Gutierrez;

"CARRIED UNANIMOUSLY."

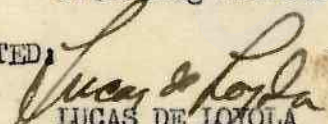
