RESOLUTION NO. 1

"WHEREAS, the Parent-Teachers' Association and the residents of Cogon Community, this City, have filed a petition with this Body requesting an appropriation to cover the purchase of the land now occupied by the Cogon Community School, and at the same time effect the acquisition of the lot by way of purchase or by expropriation proceedings;

"WHEREAS, the same petition mentioned above stated that the owner of the lot in question, Col. Segundo G. Vergara, has signified his willingness to donate one-half hectare or 5,000 sq. m. to the school, and the other half hectare to be paid by the school at a reasonable price;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Ocubillo;

"RESOLVED, as it is hereby resolved, to authorize one of the members of this Board in the person of Vice Mayor Rafael M. Mejia, to negotiate with Col. Segundo G. Vergara, owner of the land now occupied by the Cogon Community School, in order to effect a formal acquisition of said land for the school by way of buying one-half hectare of said land and legalizing the donation of the other half;


"RESOLVED FINALLY, to furnish copies of this resolution each to Vice Mayor Rafael M. Mejia, the District Supervisor, Ormoc I, and the PTA President, Cogon Community, all of Ormoc City; and the Division Superintendent of Schools, Tacloban.
