RESOLUTION NO. 3

"WHEREAS, there is a balance unpaid and due to Angela Torres, heirs of the late Nicolas Torres, under CTO Voucher No. 1268 and CA Voucher No. 3191 representing a portion of a road right-of-way claim, which amount (P835.80) was not collected when the aforesaid voucher was drawn due to lack of Special Power of Attorney on the part of the heirs of Angela Torres;

"WHEREAS, the heirs of Angela Torres have now submitted a duly accomplished Special Power of Attorney which this Body believes will meet the requisite for the complete payment of said road right-of-way;

"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to appropriate the amount of P835.80 from out of the roads and bridge fund, to be made available for the payment of the balance due to the heirs of Angela Torres, heir of Nicolas Torres, said balance unpaid under CTO Voucher No. 1268 and CA Voucher No. 3191 due to lack of Special Power of Attorney on the part of the heirs of Angela Torres when said voucher was drawn;

"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Engineer, the City Auditor, and to the representative of the heirs of Angela Torres, all of Ormoc City.

"CARRIED, Unanimously."
