RESOLUTION NO. 5

"WHEREAS, in view of the reduction of the internal revenue allotment accruing to the city intermediate school fund by ₱13,698.96 as per memorandum submitted to this Board by the City Treasurer, the budget of same would therefore be deficient of this amount which is sufficient to hamper the functions of the city intermediate schools if this deficiency is not covered up;

"WHEREAS, in the same memorandum aforesaid, the City Treasurer recommended that this deficiency be covered up by reversion of the salary savings from the different city departments (General Fund) to the unappropriated account and the same appropriated for transfer from the General Fund to the City Intermediate School Fund to balance the budget of the latter;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilors Penserga and Du;

"RESOLVED, as it is hereby resolved, to revert the amount of ₱13,698.96 from out of the salary savings of any and all departments of the city paid out from the general fund, to the unappropriated account;

"RESOLVED FURTHER, that the aforesaid amount which is hereby reverted from the salary savings to the unappropriated account of the general fund, be, as it is hereby, transferred from the General Fund to the City Intermediate School Fund, in order to balance the budget of the latter;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Secretary of Finance, Manila; the Division Superintendent of Schools, Tacloban City; the City Treasurer, the City Auditor and the District Supervisors of Ormoc I and II districts, all of Ormoc City.

"CARRIED, Unanimously."


