RESOLUTION NO. 6

"WHEREAS, this Board, in its regular session held on September 20, 1957, passed Resolution No. 176 requesting funds for the construction of a sea wall along the shores of barrios Alegria, Punta and Batuan, Ormoc City;

"WHEREAS, in an 8th indorsement relative to the matter, the Director of Public Works advised that, due to the fact that the Bureau of Public Works has no available fund for the survey of this project, an amount of P300.00 should be provided by this City in order to facilitate an earlier survey; and

"WHEREAS, this Board, in its desire to protect lives and properties along the area which is being gradually eroded by the action of the waves, deems it urgent to provide funds for an earlier survey of the proposed project so that the same may be materialized as soon as possible;

"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to appropriate the sum of P300.00 from out of any funds existing in the city treasury not otherwise appropriated, to be expended for the survey of the proposed sea wall along the shores of barrios Alegria, Batuan and Punta, as per advise by the Director of Public Works contained in an 8th indorsement dated May 2, 1958, relative to the matter;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Executive Secretary, Malacañang, Manila; the Secretary of Public Works & Communications, Manila; the Director of Public Works, Manila; the City Treasurer, the City Engineer and the City Auditor, all of Ormoc City.

"CARRIED, Unanimously."


