RESOLUTION NO. 7

Letter of the City Engineer, this City, quoted verbatim hereunder as follows:

S i r :

This is with reference to Resolution No. 3, series 1959, appropriating the amount of P835.80 from out of the roads and bridge fund for the payment of the balance due to the heirs of Angela and Nicolas Torres.

It appears from Resolution No. 139, series 1958 (page 15), that the road and bridge fund was wholly appropriated as the City counterpart fund for the maintenance of City roads, streets, and bridges, as required in Sec. 8(b) of R.A. 917. As such, no amount thereof could be appropriated for any other purpose, much less for the apyment of right-of-way claims. However, any amount from the road and bridge fund in excess of the City Counterpart maintenance fund of P75,235.00 may be appropriated by the Municipal Board for the city road and bridge improvement or construction projects, including payment for city road right-of-way claims. In case the road and bridge fund is just enough for the City counterpart maintenance funds, the funds for city road and bridge improvement and construction projects, and payments for city road right-of-way claims should be appropriated from the general fund.

"RESOLVED, to appropriate, as is hereby appropriated, the amount of P835.80 from out of the General Fund to be made available for the payment of the balance due to the heirs of Angela Torres, heir of Nicolas Torres, said balance unpaid under CTO Voucher No. 1268 and CA Voucher No. 3191 due to lack of Special Power of Attorney on the part of the heirs of Angela Torres when said voucher was drawn, whenever funds are available."

"RESOLVED, FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Engineer, the City Auditor and to the representative of the heirs of Angela Torres, all of Ormoc City."


