"RY DIVED, to repeal, as is hereby repealed, Resolution No. 108, series of 1957, thereby restoring the annual festival celebration de of Ormoc City to its historically famous, traditionally observed and universally known date of June 29 of each year;

"RESOLVED, FINALLY, to furnish copies of this resolution each to the Honorable Executive Secretary, Manila; and to the Office of the Catholic Parish, the Knights of Columbus and the Catholic Women's League, all of Ormoc City; "CARRIED. One Abstention (by Councilor Cesar Samson)"
