RESOLUTION NO. 8

"WHEREAS, considering lengthily the effect of the implementation of Resolution No. 108, series of 1957, of this Body transferring the date of the annual city festival of Ormoc from June 29 to the fourth Sunday of May of each year;

"WHEREAS, finding out that this setup as carried through on the fourth Sunday of May, 1958, caused so much trouble, inconveniences and misunderstandings among the greater segment of the city populace as well as a dislocation of the overall religious and economic picture of Ormoc City society, thereby defeating the laudable purpose for which the transfer of celebration date has been made;

"WHEREAS, realizing that it is the consensus of opinion of the great majority of the Ormocanos, both native and transient, an opinion shared by the Knights of Columbus, the Catholic Women's League, and the office of the Catholic Parish of this City that last year's experiment was a failure and that a return to status quo has therefore become an imperative necessity;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Ihaki Larrazabal;

"RESOLVED, to repeal, as is hereby repealed, Resolution No. 108, series of 1957, thereby restoring the annual festival celebration date of Ormoc City to its historically famous, traditionally observed and universally known date of June 29 of each year;


"RESOLVED, FINALLY, to furnish copies of this resolution each to the Honorable Executive Secretary, Manila; and to the Office of the Catholic Parish, the Knights of Columbus and the Catholic Women's League, all of Ormoc City;

"CARRIED. One Abstention (by Councilor Cesar Samson)"


