Letter of the Chief of Police, this City, quoted verbatim here-

In the name of the Ormoc City Police Department, the undersigned have the honor to request the Hon. Municipal Board, Ormoc City, that an amount reasonable enough, aside from any government compensation the deceased is entitled to, be appropriated for the assistance of bereaved family of the late Patrolman Guillermo Magno who gave his life away while in the performance of his official duty at about 8:40 A.M. January 13, 1959.

Subject died with honorable death while assigned as guard to maintain peace and order in the strike-bound OWFLU organization against the OSCO management at BBo. Ipil, Ormoc City.

Our benevolent assistance in one way or another would be worthy of emulations as a token of condolence to the family of the departed soul. The deceased has never been insured in any government or private insurance company which might alleviate the sufferings and worries of the family who shall be left destitute, hence the foregoing request.

"RESOLVED, to appropriate, as is hereby appropriated, the amount of P600.00 from out of the General Fund as a City counterpart, in accordance with Republic Act No. 784, to be made available for the payment of compensation to the bereaved family of the late Patrolman Guillermo Magno of the Ormoc City Police Department who died in line of duty, aside from other emoluments and benefits accrued to him;


"RESOLVED, FINALLY, to furnish copy of this resolution each to the Honorable Executive Secretary and the Commissioner of Civil Service, both of Manila; and to the City Treasurer, the City Auditor, the Chief of Police, and Mrs. Margarita vda. de Magno, all of Ormoc City;

"CARRIED UNANIMOUSLY."


