RESOLUTION NO. 10

"WHEREAS, the Municipal Board, after careful deliberation, has considered very urgent the repair of the old market building which is now almost in a dilapidated state;

"WHEREAS, said old market building is giving a good income each month and yet the lessees of the market stalls are not given the necessary facilities due to leakages of the roofing besides being dark inside even during daytime;

"WHEREAS, enough funds can be had to cover the repair expenses by suspending in the meanwhile the construction of the gutters, downspouts and painting of the slaughterhouse which was newly constructed from out of the loan from the Development Bank of the Philippines, inasmuch as without these, the slaughterhouse can already be used;

"WHEREAS, part of said loan have also been earmarked by the City Engineer for the improvement of the sidewalk of the market compound along Real Street and of the construction of the awning of the "I" stalls along Rizal Street, although these projects are not yet and, therefore, the appropriation for the same may be directed to the repairs of the old market building;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Cesar Samson;


"RESOLVED, to request, as is hereby requested, the Development Bank of the Philippines to authorize the diversion of that part of the loan intended for the construction of the gutters, downspouts and painting of the slaughterhouse, the improvement of the sidewalk of the market compound along Real Street, and the construction of the awning of the "I" stalls along Rizal Street, which projects have been eliminated in the original contract approved by this Board and submitted to the Development Bank of the Philippines, to the repairs of the old market building;


