RESOLUTION NO. 11

"WHEREAS, the Honorable Ildefonso Sinco, Provincial Governor of Leyte, in his capacity as contractor with the NASSCO for the salvaging of sunken war vessels within the territorial waters of Ormoc Bay, has offered Ormoc City 25% of the proceeds accruing to the provincial government of Leyte in connection with the salvaging operations as well as the right to supply the labor and other facilities relative thereto;

"WHEREAS, in token of appreciation of this gesture of the Honorable Provincial Governor, the City will provide the subcontractors with the necessary protection and conveniences during the period of salvaging operations;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Marciano S. Du;


"RESOLVED, as it is hereby resolved, to accept the offer of the Honorable Provincial Governor to Ormoc City appertaining to the 25% of the proceeds and to the right to supply the labor and other facilities relative to the salvaging of sunken war vessels within the territorial waters of Ormoc Bay.

"RESOLVED, FURTHER, to assure the Honorable Provincial Governor of all the necessary protection and conveniences to the subcontractors during the period of salvaging operations;


"RESOLVED, FINALLY, to furnish copies of this resolution each to the Honorable Provincial Governor, Tacloban City; the NASSCO, Manila; the subcontractors, c/o the Honorable Provincial Governor, Tacloban City; the Commanding Officer, 59th PC Co., Camp Downes, Ormoc City; and the Chief of Police, Ormoc City."
