RESOLUTION NO. 13

"WHEREAS, the Market Superintendent, Ormoc City, executing Ordinance No. 5, series of 1951 (re zoning of public market stalls), has advised in writing last January 2, 1959, the operators or owners of billiard tables occupying public market stalls to remove such billiard tables from the market premises within 30 days from said date;

"WHEREAS, the owners of these billiard tables have made representations with this Body requesting that in view of the limited and short time element given them with which to transfer their billiard tables which are the only source of their daily bread, and in view of their inability at present to look for a place wherein to transfer their tables, they be allowed to stay in their places until May 31, 1959; and

"WHEREAS, this Body, considering that the daily income of these billiard tables is very small to support or finance the construction of a place wherein they could transfer, favors the granting of the requested extension of their stay in the market until May 31, 1959;


"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez, seconded by Councilors Larrazabal and Tan, Jr.;

"RESOLVED, as it is hereby resolved, to allow these billiard tables and pools to remain operating in the market premises until May 31, 1959;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, the Market Superintendent and Mr. Pablo Ablen, all of Ormoc City.

"CARRIED, Unanimously."


