RESOLUTION NO. 14

"WHEREAS, the Senior Clerk of this Board, Mr. Ireneo B. Leal, has been extended a permanent appointment by the City Mayor in view of his passing the General Clerical Examinations given by the Bureau of Civil Service in Ormoc City on December 22, 1956;

"WHEREAS, pursuant to the provisions of Sec. 2, Republic Act 660, amending Sec. 4 of Commonwealth Act 186, membership in the Government Service Insurance System shall be compulsory upon all regularly and permanently appointed employees; and

"WHEREAS, the government entity who has an employee who is a member of the System, also shares in paying the insurance and retirement premiums of said employee;


"NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilors Tan, Jr. and Gutierrez;

"RESOLVED, as it is hereby resolved, to revert from out of the per diem savings of the Municipal Board, the sum of P54.00 to cover the city's share of the insurance and retirement premiums of Mr. Ireneo B. Leal from February to June, 1959;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Regional Manager, Government Service Insurance System, Cebu City; the City Treasurer and the City Auditor, both of Ormoc City.

"CARRIED, Unanimously."


