RESOLUTION NO. 15

"WHEREAS, during the widening of the city streets, the government used and occupied 12 square meters (Lot No. 575-A) and 16 sq. meters (Lot No. 575-C) of land owned by the spouses Cresencio Eugenio and Flora Mejia, located at Lopez Jaena St.; and

"WHEREAS, the value of the land affected according to the schedule of values of city lots located in the business section is P30.00 per square meter; and

"WHEREAS, the land owners above mentioned are claiming payment of their lots which are covered by a road right-of-way agreement; and

"WHEREAS, the payment of the aforesaid lots is an obligation of the city to the land owners to compensate for their property used by the city for road purposes;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilors Du and Gutierrez;

"RESOLVED, as it is hereby resolved, to approve the road right-of-way claim of the spouses Cresencio Eugenio and Flora Mejia for the payment of their lots used by the city to widen Lopez Jaena St., hereby authorizing the payment therefor as soon as funds are made available, at P30.00 per square meter;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Engineer, the City Auditor and Mr. and Mrs. Cresencio Eugenio, all of Ormoc City.

"CARRIED, Unanimously."


