RESOLUTION NO. 18

"WHEREAS, during the widening of the city streets, the city used and occupied 39 square meters of land owned by Luisa Codilla Sy situated along Arradaza Street, particularly known as Lot No. 359 of the Cadastral Survey of Ormoc;

"WHEREAS, in a special meeting held by the Appraisal Committee, Ormoc City, the aforementioned lot was appraised at ₱10.00 per sq. meter per resolution (unnumbered) dated Feb. 4, 1959; and

"WHEREAS, the landowner is claiming payment of her lot, and for which this Body feels it an obligation of the city to the said landowner to compensate her property used by the city for road purposes;


"NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilor Larrazabal;

"RESOLVED, as it is hereby resolved, to approve the road right-of-way claim of Mrs. Luisa Codilla Sy, hereby appropriating for the payment thereof, the sum of ₱390.00 from the city general fund not otherwise appropriated;

"CARRIED, Unanimously."


