EXCERPT FROM THE MINUTES OF THE SPECIAL SESSION OF THE MUNICI-PAL BOARD OF ORMOC CITY, PHILIPPINES, HELD IN ITS SESSION HALL ON FEBRUARY 10, 1959

RESOLUTION NO. 2

"WHEREAS, this Board, in its regular session held on January 16, 1959, passed Resolution No. 9, appropriating 1600.00 for the compensation of the family of the late Pat. Guillermo Magno of the Ormoc City Police Department who died in line of duty at the incident in the strike bound O moc Sugar Company on January 13, 1959, pursuant to the provisions of Republic Act 784;

"WHEREAS the City Auditor, Ornoc City, in a 2nd indorsement relative to the matter dated February 3, 1959, disapproved the herein city counterpart of the compensation based on the provisions of Republic Act 784, stating that the said Act is not applicable to the members of city policemen (Teofila &. Tibon, vs. the Amorable Auditor General, G.R. No. L-7065; Vol. 51, 10. 4 Pp. 1322-3, Official Gazette), and suggested that the case may be presented under the provisions of Republic Acts Nos. 30 and 1232; and

HEREAS, Republic Act 1232 provides that "if a person in such service is killed or dies of injuries received or sickness # contracted in line of duty, the Department Head shall authorize the payment of reasonable burial expenses and of six month's salary or wages in no case less than one thousand pesos to the surviving spouse or dependent child or children of such deceased person" and further provides that "for employees of a city the time allowance and disbursements contemplated above shall not be granted except upon recommendation of the Municipal Board or council of the city";

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Samson;

"RESOLVED, as it is hereby resolved, to amend Resolution No. 9, c.s., so that instead of basing the compensation to be extended to the family of the late Pat. Guillermo Magno from the provisions of Republic Act 784, the same be made pursuant to the provisions of Republic Act 1232, hereby appropriating for the purpose, the sum of One Thousand Pesos (F1,000.00) from out of any funds existing in the City Treasury not otherwise appropriated, and recommending pursuant to the Brovisions of Republic Act 1232, that this compensation to the family or to the widow of the late Pat. Magno be paid as soon as possible;

"RESOLVED FINALMY, to furnish copies of this resolution each to the Executive Secretary, Malacañang, Manila; the City Treasurer, the City Auditor, the Chief of Police, and Mrs. Margarita Vda de Magno, all of Ormoc City.
