RESOLUTION NO. 26

"WHEREAS, on December 9, 1958, the Honorable City Mayor, in behalf of the city government of Ormoc City, and Engr. Fortunato T. Sanchez, executed a contract (supplemental) for the construction of downspouts, gutters and painting of the Slaughterhouse in Alegria and the Market Tiendas in Valencia;

"WHEREAS, in a letter to this Body dated December 11, 1958, the City Engineer submitted the said contract for approval by this Body, pursuant to Article V thereof which provides that the same is subject to the approval of this Board; and

"WHEREAS, after a thorough study on the matter, this Board is convinced that said contract is in order, and is necessary for the completion of the projects aforementioned;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to approve the aforesaid supplemental contract for the construction of the downspouts, gutters and painting of the Slaughterhouse in Alegria and the Market Tiendas in Valencia;
