RESOLUTION NO. 29

"WHEREAS, this Board passed Resolution No. 147-B on September 12, 1958 designating as National-Aid city streets the city streets enumerated therein, upon recommendation of the City Engineer;

"WHEREAS, in a 1st indorsement relative to the matter, the Chief Programming & Planning Engineer, Bureau of Public Highways, Manila, returned said Resolution No. 147-B for revision to include the stationings or termini of San Pedro, San Pablo and Mabini Sts. and also an equivalent length of 1.062 kms. to be subtracted preferably from the Valencia-Sabang Road; and

"WHEREAS, the City Engineer, this City, following the suggestion of the Chief Prog. & Plan. Engr. contained in the 1st indorsement aforesaid, recommended the following proposed revision of "National-Aid" City Roads and Streets, to wit:

San Pedro St. (From San Agustin St. to between	
C. Aviles St. and Obrero St.) .....	0.370 km.
San Pablo St. (From San Agustin St. to	
C. Aviles St.) .....	0.318 km.
Mabini St. (From Burgos St. to Osmeña St.) ...	0.374 km.
Valencia-Sabang Road, Km.97.250-Km.100.528 ...	3.278 km.
Ormoc-Merida Road, Km.107.517-108.517 .....	1.000 km.
Total .....	5.310 Kms.

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to approve the foregoing revision as recommended by the City Engineer, this City, hereby amending for the purpose, Resolution No. 147-B, series of 1958 of this Board, to conform with the foregoing;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Commissioner of Public Highways, Manila; the Highway Division Engineer, 4th Engineering Division, Cebu City; the City Engineer, the City Treasurer and the City Auditor, all of Ormoc City.

"CARRIED, Unanimously."


