RESOLUTION NO. 32

"WHEREAS, the City Attorney, this City, acting on a verbal request made by this Board to give an opinion on (a) whether Ormoc City is within the purview of Republic Act 1408, (b) as to who has the authority to appoint rural policemen in Ormoc City, and (c) whether rural policemen are prohibited by law to enter into active partisan politics, submitted in writing his observations on the matter based upon the laws cited therein; and

"WHEREAS, this Board further desires a legal opinion on the points enumerated above from the Honorable, the Secretary of Justice;


NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilor Ocubillo;

"RESOLVED, as it is hereby resolved, to indorse the observations of the City Attorney, Ormoc City, to the Secretary of Justice, Manila, for legal opinion on the points listed above, and with the additional information that as pertains to (a), Ormoc City has within its jurisdiction and is comprised of 54 barrios each of which has a barrio lieutenant due for election every year in accordance with the Barrio Election Law;


"RESOLVED FINALLY, to forward a copy of this resolution to the Secretary of Justice, Manila, for consideration; and a copy furnished the City Attorney, Ormoc City;

"CARRIED, Unanimously."


