RESOLUTION NO. 34

"WHEREAS, Pat. Emilio Enero has submitted a voucher in his favor for the reimbursement of actual and necessary expenses during his hospitalization; and

"WHEREAS, under the provisions of Sec. 699 of the Revised Administrative Code, as amended by Republic Act 1232, Pat. Enero is entitled to the payment of his medical attendance and hospital fees upon authority of the proper Head of Department;


"NOW, THEREFORE, the Board, on motion of Councilor Larrazabal, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to recommend that Pat. Emilio Enero be granted reimbursement of his payments made for his medical attendance, hospital fees and other expenses in connection with the treatment of his service connected illness, pursuant to the provisions of Sec. 699 of the Revised Administrative Code as amended, hereby appropriating for the purpose, the sum of ₱293.00 from out of any funds existing in the city treasury not otherwise appropriated;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Executive Secretary, Malacañang, Manila; the City Treasurer, the City Auditor, the Chief of Police, and Pat. Emilio Enero, OCPD, all of Ormoc City.
