RESOLUTION NO. 40

"WHEREAS, during the widening of city streets the City used and occupied for road purposes Lot No. 718 of the Ormoc Cadastre covered by TCT No. 2376, owned by Purita C. Peñalosa et al, and Lot No. 1011 covered by TCT No. 1943 decreed to the spouses Basilio P. Codilla and Vicenta O. Carrillo;

"WHEREAS, the road right of way agreement of the former lot involves an area of 37 sq. m. and that of the latter is 28 sq. m., both lots appraised by the Appraisal Committee, Ormoc City, at ₱15.00 per square meter; and

"WHEREAS, the owners of the lots above mentioned are now filing a claim for payment of their lots and for which this Board feels it an obligation of the City to pay said claims inasmuch as their lots have already been used and occupied by the city for road purposes;


"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to approve the road right-of-way claim of Purita C. Peñalosa, et al, and the spouses Basilio P. Codilla and Vicenta O. Carrillo, hereby authorizing the payment therefor at the rate of ₱15.00 per square meter as soon as funds are made available for the purpose;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, the City Engineer, Miss Purita C. Peñalosa and Mr. Basilio P. Codilla, all of Ormoc City.

"CARRIED, Unanimously."


