"WHEREAS, the road right of way agreement of the former lot involves an area of 37 sq. m. and that of the latter is 28 sq. m., both lots appraised by the Appraisal Committee, Ormoc City, at F15.00 per aquare meter; and

"MEREAS, the owners of the lots above mentioned are now fling a clair for payment of their lots and for which this Board feels it an obligation of the City to pay said claims inasmuch as their loth have already been used and occupied by the city for road purposes;
