RESOLUTION IN. 4

"WHEREAS, in a letter to this Body, Col. Segundo Vergara expressed his willingness to donate one-half bectare of his land now occupied by the school building at Cogon Combato, with a frontage of 50 meters instead of 'N meters as had been agreed upon during the session in Cogon Combado of March 20, 1959;

"WHEREAS a 50-meter from age is very inadequate for school site purposes considering that a school plaza needs a wider space for play, round; and

WHERA'S this body believes that by accepting a half-hec-tare conation and buying the other half hectare at P1.00 per square letter (the price offered in the letter above-mentioned), the city is not raying for only one-half hectare but about five times the cost of the whole hectare;

"NM, THEREFORE, the Board, on motion of Councilor Parriala, seconded by Councilor Samson;

"RESOLVED, as it is hereby resolved, to request the City Mayor, Ormoc City, to appoint a three-man committee to contact Col. Segundo Vergara on March 29th, 1959, and to tell him that the city is not in a position to accept the donation with the conditions stated in his letter;

"RESOLVED FINALLY, to furnish copies of this reclution each to the members of the committee to be appointed by the City Mayor. "CARRIED, Unanimously."

(Note: The following were appointed in open session to constitute the committee: Vice Mayor Mejia as Chairman, and Councilors Parrilla and Penserga as members.)
