EXCERPT FROM THE MINUTES OF THE REGULAR SESSION OF THE MUNICIPAL BOARD OF ORMOC CITY, PHILIPPINES, HELD AT THE SCHOOL BUILDING OF BARRIO LILOAN ON WEDNESDAY, MARCH 25, 1959, IN LIEU OF FRIDAY, MARCH 27, 1959

RESOLUTION NO. 47

"WHEREAS, in a letter to this Body, Col. Segundo Vergara expressed his willingness to donate one-half hectare of his land now occupied by the school building at Cogon Combado, with a frontage of 50 meters instead of 70 meters as had been agreed upon during the session in Cogon Combado on March 20, 1959;

"WHEREAS, a 50-meter frontage is very inadequate for school site purposes considering that a school plaza needs a wider space for playground; and

"WHEREAS, this Body believes that by accepting a half-hectare donation and buying the other half hectare at P1.00 per square meter (the price offered in the letter above-mentioned), the city is not paying for only one-half hectare but about five times the cost of the whole hectare;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Samson;

"RESOLVED, as it is hereby resolved, to request the City Mayor, Ormoc City, to appoint a three-man committee to contact Col. Segundo Vergara on March 29th, 1959, and to tell him that the city is not in a position to accept the donation with the conditions stated in his letter;

"RESOLVED FINALLY, to furnish copies of this resolution each to the members of the committee to be appointed by the City Mayor.


"CARRIED, Unanimously."

(Note: The following were appointed in open session to constitute the committee: Vice Mayor Mejia as Chairman, and Councilors Parrilla and Penserga as members.)
