RESOLUTION NO. 50

"WHEREAS, Mr. Ismael Jaballes, Driver of the City Mayor, has been issued an insurance policy by the Government Service Insurance System in which the city government of Ormoc has a share in the payment of its premiums at the rate of P5.04 a month from January 1, 1959; and

"WHEREAS, aside from the life insurance premiums, the city also has a share in his retirement gratuity premiums at P7.20 a month also from January 1, 1959 to June 30, 1959, after which the city's share of his insurance and retirement premiums shall be incorporated in the city budget for the next fiscal year;

"NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilors Du and Gutierrez;

"RESOLVED, as it is hereby resolved, to appropriate the sum of P73.44 from out of the per diem savings of the Municipal Board, to cover the life insurance and retirement premiums of Mr. Ismael Jaballes, Driver of the City Mayor, from January 1, 1959 to June 30, 1959;

"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, both of Ormoc City; and the Regional Manager, GSIS, Cebu.


