RESOLUTION NO. 52

"WHEREAS, pursuant to Administrative Order No. 41, dated March 17, 1959 of the Honorable, the Secretary of Justice, Atty. Jose C. Alfaro, Justice of the Peace of Albura, Leyte, acted as Municipal Judge of Ormoc City from March 12-29, 1959, during the absence of Municipal Judge Pascual Berciles who went to Manila on official business; and

"WHEREAS, Art. XIII, R.A. 179, otherwise known as the Charter of Ormoc City, provides that if a Justice of the Peace is so designated to act as Municipal Judge of the City in the absence of the Municipal Judge and the Auxiliary Municipal Judge, the Justice of the Peace so designated shall, in addition to his salary, receive 70% of the salary of the Municipal Judge whose office he has temporarily assumed;


"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Pensergera and Vice Mayor Mejia;

"RESOLVED, as it is hereby resolved, to appropriate the sum of P167.96 from out of the salary savings of the Municipal Court, to be paid for the services rendered of Judge Jose C. Alfaro of Albura, who acted as Municipal Judge of Ormoc City from March 12-29, 1959, during the absence of Municipal Judge Pascual G. Berciles;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, the Municipal Judge, and of Ormoc City; and Judge Jose C. Alfaro, Albura, Leyte.

"CARRIED, Unanimously."


