RESOLUTION NO. 55

"WHEREAS, the residents of barrios Alegria and Batuan have made representations with this body soliciting the help of the Board to request the Division Superintendent of Schools for Leyte to open Grades I and II classes in said barrios this coming school year to open on June 8, 1959 and to assign two teachers to take charge of these classes;

"WHEREAS, the barrio people of said barrios have already signified their willingness to construct a temporary school building on a self-help project to be known as Alegria Primary School on a public land reserved by this body for school site; and

"WHEREAS, they have shown evidence of sufficient enrolment which would warrant the opening of the classes and the assigning of two teachers;

"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to request the Division Superintendent of Schools, Tacloban City, thru the District Supervisor, Ormoc I, Ormoc City, to reopen Grades I and II classes in Alegria, Ormoc City, this coming school year to open on June 8, 1959, for the reasons already stated above;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Division Superintendent of Schools, Tacloban City, thru the District Supervisor, Ormoc I, Ormoc City; the Barrio Lieutenant of Alegria, Ormoc City; and the Barrio Lieutenant of Batuan, Ormoc City.

"CARRIED, Unanimously."


