## RESOLUTION NO. 55

WHEREAS, the residents of Darrios Alegria and Batton have made representations with this lody coliniting the help of the Board to request the Division Superintendent of Schools for Leyte to open Grades I and II classes in said berrios this coming school year to open on June 8, 1957 and to assign two teachers to take charge of these classes;
