RESOLUTION NO. 27

Letter of the City Health Officer, this City, dated April 2, 1959, quoted verbatim hereunder, reads:

Dear Sirs:

In our inspection of the new market building at Bo. Valencia this City, it was found out that there is no source of water supply for drinking and washing purposes of the market vendors. Also it was found out that there is no public toilet in that market.

It is earnestly recommended for the good of public health that before said market is opened to the public that an artesian well be first provided for drinking and washing purposes of the market vendors and buyers. At the same time also a public toilet be provided also before it is opened to the public.

It is hoped that Honorable Body will have these requirements of the public market at Bo. Valencia this city be constructed as soon as possible before the market is opened to the public.

"WHEREAS, as regards the request for a water supply as mentioned in the above-quoted letter, this Body believes that the same comes under the jurisdiction of the MWSA;

(RESOLUTION NO. 57, SERIES OF 1959 - MUNICIPAL BOARD, ORMOC CITY)

"WHEREAS, this Body further believes that instead of an artesian well as recommended, a waterworks system is more convenient and more economical in the long run; and

"WHEREAS, this Body has learned that there is a sufficient source for a waterworks system from Barrio Masarayao which is about two kilometers from Valencia;

"NOW, THEREFORE, the Board, on motion of Councilor Larrazabal, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to request the National Waterworks Authority thru the Waterworks Supervisor, Ormoc City, to install or cause to be installed, a waterworks system for the use of the public market in Valencia, from a spring in Barrio Masarayao;

"RESOLVED FINALLY, to furnish copies of this resolution each to the General Manager, National Waterworks and Sewerage Authority, Manila; the Waterworks District Engineer, Tacloban City; and the Waterworks Supervisor, Ormoc City.

"CARRIED, Unanimously."
