RESOLUTION NO. 60

Resolution No. 414, series of 1958, of the Provincial Board of Sulu, petitioning His Excellency, the President of the Philippines, Malacañang, and the Hon. Secretary of Finance, Manila, to revise the latest ruling of the Commissioner of Internal Revenue in favor of the coconut planters and producers, by maintaining and upholding the ruling dated January 30, 1958, of that same Bureau of Internal Revenue to the effect that copra is exempt from the sales tax under the provisions of Republic Act 1612 when sold in this country by the producer thereof or owner of the land where it is produced, was presented.

"WHEREAS, this body sympathizes and concurs in the embodiments of the aforesaid resolution of the Provincial Board of Sulu;


NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Gutierrez;



"CARRIED, Unanimously."


