"WHEREAS, in a letter to the City Engineer dated April 15, 1959, Engr. Fortunato T. Sanchez, Contractor for the Alegria Slaughterhouse and the Valencia Market Building, has advised that these two buildings constructed under contract had been completed, and requested that the same be finally inspected and accepted;

"WHEREAS, on April 16, 1959, the Office of the City Engineer conducted an inspection on the above mentioned projects, after which the said office certified that the constructions had been done in full accordance with the plans and specifications; and

"WHEREAS, in a 1st indorsement relative to the matter, the City Engineer has recommended the acceptance of the Slaughterhouse at Alegria and the Market Tiendas at Valencia;


"NOW, WHEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Penserga;

"CARRIED, Unanimously."


