RESOLUTION NO. 63

"WHEREAS, during the widening of city streets the city used and occupied 55 square meters of the land owned by the Dixon and Bonsilao family, situated at Mabini St. particularly known as Lot No. 1259 under OCT No. 13532;

"WHEREAS, the road right-of-way agreement executed by the landowners and the City Mayor in behalf of the City, stipulates that in consideration of the granting to the city of a road right-of-way, the landowners shall be paid by the city the sum of P15.00 per square meter of land used, which rate is also the rate prescribed by the Appraisal Committee; and

"WHEREAS, the landowners above mentioned are now requesting payment for their land and for which this Body considers an obligation of the city to the said landowners to compensate for their property used for road purposes;


"NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to approve the road right-of-way claim of Romana Dixon, et. al, and authorizing the payment thereof at P15.00 per square meter or an aggregate sum of P825.00 as soon as funds are made available for the purpose;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, the City Engineer, and Mr. Tranquilino Sanchez, Attorney-in-fact of the claimants, all of Ormoc City.

"CARRIED, Unanimously."


