"WHEREAS, this Board has been furnished a copy of Resolution No. 3218 of the City Council of Basilan, requesting the President of the Philippines to suspend the construction of the Luzon super highways for which an appropriation of ONE HUNDRED THIRTY-SIX (P136) MILLION PESOS is proposed and to divert said funds towards the construction of National Highways and Feeder Roads throughout Mindanao; and

"WHEREAS, this Body feels and sympathizes with the sentiments expressed in said resolution, and is of the opinion that instead of constructing super highways in Luzon, Mindanao should be given more attention as regards the construction of highways and feeder roads in order to develop the "land of promise";


NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Parrilla;

"RESOLVED, as it is hereby resolved, to concur in and adhere with, the embodiments of Resolution No. 3218, series of 1958 of the City Council of Basilan, hereby requesting further, the President of the Philippines to suspend the construction of the Luzon super highways and divert the appropriations therefor towards the construction of national highways and feeder roads throughout Mindanao;

"CARRIED, Unanimously."


