RESOLUTION NO 68

"WHEREAS, the president of the Parents-Teachers Association of Simangan, Ormoc City, had made representations to this Body in behalf of the said association informing this Body that their schoolhouse is totally ruined and as such a new schoolhouse is imperatively necessary for this coming school year;

"WHEREAS, the president of the Parents-Teachers Association of Simangan, Ormoc City, had asked only the sum of Two Hundred Fifty Pesos (P250.00) as a barrio aid in order to materialize the construction of a new schoolhouse;

"WHEREAS, the president of the Parents-Teachers Association of Simangan, Ormoc City, had assured this Body that the Association will supply the necessary labor and materials that would be lacking in connection with the construction of same;

"WHEREAS, the amount of Two Hundred Fifty Pesos could be reverted from the salary savings of some City Departments;

"NOW, THEREFORE, the Board, on motion of Councilor Emilio C. Penserga, seconded by Councilor Marciano S. Du;

"RESOLVED, as is hereby resolved, to revert the amount of TWO HUNDRED FIFTY PESOS (P250.00) from the salary savings of the City Departments and the same to be made available for payment of the construction of a new schoolhouse in Simangan, Ormoc City;

"RESOLVED FINALLY, to furnish copy of this resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the City Engineer and the Parents-Teachers Association of Simangan, all of Ormoc City.

"CARRIED UNANIMOUSLY."
