
"NOW, THEREFORE, the Board, on motion of Councilor Marciano S. Du, seconded by Councilor Emilio C. Penserga;


"RESOLVED, as is hereby resolved, that these sections of roads and streets be declared as first class roads and streets for the City of Ormoc;


