RESOLUTION NO. 75

"WHEREAS, the residents of barrio Ipil have expressed their desire through Councilor Du, that they want to avail of the facilities of electric lights from the Ormoc Electric Company;

"WHEREAS, according to the barrio people of Ipil, before the war there was a line extended by the same company to said barrio from the city; and

"WHEREAS, this Body understands that the Ormoc Sugar Company at Ipil is willing to extend its lines outside its compound but then by doing so would require the permission from the franchisee, the Ormoc Electric Company, if the latter could not furnish its facilities to barrio Ipil;

"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Penserga;


"RESOLVED, as it is hereby resolved, to request the Ormoc Electric Company to extend its facilities to barrio Ipil as they had done before the war;

"RESOLVED FURTHER, that should the Ormoc Electric Company refuse to extend its facilities to barrio Ipil, the Ormoc Sugar Company be given permission to furnish lights to the people of said barrio;


"RESOLVED FINALLY, to furnish copies of this resolution to the Aboitiz & Co., Inc., Juan Luna St., Cebu City; the Manager, Ormoc Electric Company, Ormoc City; the Manager, Ormoc Sugar Company, Ipil, Ormoc City; and the Barrio Lieutenant, Ipil, Ormoc City.

"CARRIED, Unanimously."
