RESOLUTION NO. 8

"WHEREAS, the 10th World Jamboree Provincial Committee of the Leyte Council, Boy Scouts of the Philippines, in a meeting held at Tacloban City on January 31, 1959, passed Resolution No. 5 requesting this Body for a financial assistance from the city funds to help finance the Leyte delegation consisting of 300 Boy Scouts to the 10th World Boy Scout Jamboree at Makiling National Park, Los Baños, Laguna;

"WHEREAS, Mr. Eulalia Aparis, Field Scout Commissioner and Mr. Vidal Alcaraz, Neighborhood Scout Commissioner, both for Ormoc City, have made representations with this Body also requesting an aid from the city to help finance the Ormoc Boy Scout delegation to the said 10th World Boy Scout Jamboree; and

"WHEREAS, the Honorable Juan C. Pajo, Executive Secretary, in a memorandum issued at Manila on April 23, 1958, to heads of departments, bureaus and offices of all instrumentalities of the government, enjoined all officials and employees of the government to lend their assistance and cooperation to the Boy Scouts of the Philippines in connection with the holding of the World's Boy Scout Jamboree in the Philippines in July, 1959";

"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to appropriate the sum of P500.00 from out of the city general fund otherwise unappropriated, to be made available as city's aid to the Leyte and Ormoc City delegation to the 10th World Boy Scout Jamboree, the amount to be distributed as follows:

P300.00 to the Leyte Provincial Council Fund; and
200.00 to the Ormoc City delegation, c/o Mr. Eulalia Aparis and Mr. Vidal Alcaraz;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Leyte Provincial Scout Executive, Tacloban City; the City Treasurer, the City Auditor, and Mr. Eulalia Aparis, Field Scout Commissioner or Mr. Vidal Alcaraz, Neighborhood Scout Commissioner, all of Ormoc City.


"CARRIED, Unanimously."
