RESOLUTION NO. 8

Leyte Council, Boy Scouts of the Failipaires, in a meeting held at Tacloban City on January 31, 1959, passed hes lation No. 5 requesting this Body for a financial assistance from the city funds to help finance the Leyte delegation consisting of the Scouts to the 10th World Boy Scout James at Makiling National Park, Los Baños, Lagua;

WHEREAS, Mr. Edalis Aparis, Fleid Scout Commissioner and Mr. Vidal Alcaras, Neighborhood Scout Commissioner, both for Ormoc City, have made representations with this Body also requesting an aid from the city to help finance the Ormoc Boy Scout delegation to the said 10th World Doy Scout Jantones, and

WHER Was the Honorable Juan C. Pajo, Executive Secretary, in some random issued at Manila on April 23, 1958, to heads of departments bureau and offices of all instrumentalities of the government, "enjoined all officials and employees of the government to lend their assistance and cooperation to the Boy Scouts of the Philippines in June on the Philippines in July, 1959";

"NOW, THEREFORE, the Board, on motion of Councilor Gutierres, seconded by Councilor Du;

*RESOLVED, as it is hereby resolved, to appropriate the sum of \$500.00 from out of the city general fund otherwise unappropriated, to be made available as city's aid to the Leyte and Ormoc City delegation to the 10th World Boy Scout Jamboree, the amount to be distributed as follows:

200.00 to the Leyte Provincial Council Fund; and 200.00 to the Ormoc City delegation, c/o Mr. Eulalio Aparis and Mr. Vidal Alcaras;

*RESOLVED FINALLY, to furnish copies of this resolution each to the Leyte Provincial Scout Executive, Tacloban City; the City Treasurer, the City Auditor, and Mr. Eulalio Aparis, Field Scout Commissioner or Mr. Vidal Alcaraz, Neighborhood Scout Commissioner, all of Ormoc City.
