RESOLUTION NO. 82

"WHEREAS, Hon. Asuncion C. Omega, a newly appointed member of this Board, has assumed office only recently, vice Councilor Jorge P. Tan, Jr., resigned;

"WHEREAS, in view of the assumption of Councilor Omega into office as member of this Board, it is necessary that she be given a councilor district as well as a chairmanship and membership of the different standing committees of this Board; and

"WHEREAS, in order to facilitate her immediate assumption into the different committees of this Board, it has been agreed that she be authorized to assume the chairmanships and memberships of the committees formerly held by Councilor Tan, Jr., and that she be assigned to Councilor District No. III, comprising the barrios of Simangan, Maraswa, Dolores, Bagong and Sto. Niño, also formerly under Councilor Tan, Jr.;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to authorize Councilor Asuncion C. Omega, to assume the chairmanship and memberships of the different committees in this Board formerly held by Councilor Tan, Jr., and also assigning her to Councilor District No. III comprising the barrios above mentioned, hereby amending for the purpose, Resolutions Nos. 219 and 220, both series of 1957, in such a manner as to delete the name of Councilor Jorge P. Tan, Jr., wherever it is found in said resolutions, and in its stead insert the name of Councilor Asuncion C. Omega;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, and Councilor Asuncion C. Omega, all of Ormoc City.

"CARRIED, Unanimously."
