MRESOLVED, as it is hereby resolved, to authorize Councilor Asuncion C. Omega, to assume the chairmanship and memberships of the different committees in this Board formerly held by Councilor Tan, Jr., and als o assigning her to Councilor District No. III comprising the barrios above mentioned, hereby amending for the purpose, Resolutions Nos. 219 and 220, both series of 1957, in such a manner as to delete the name of Councilor Jorge P. Tan, Jr., wherever it is found in said resolutions, and in its stead insert the name of Councilor Asuncion C. Omega;
