RESOLUTION NO. 83

"WHEREAS, the Public Service Commission furnished a copy of its order setting the hearing of the application of the Ormoc Electric Company, Inc., to install an additional generating unit with a capacity of 108 Kva in its electric plant in Ormoc City, on Monday, August 3, 1959, to this Board;

"WHEREAS, this Body is interested in the hearing of this application especially that this involves the welfare of the Ormoc-anoes in general; and

"WHEREAS, in view of the distance between Ormoc and Manila, the members of this Board can not possibly proceed to Manila to appear at the hearing and possibly, also the other parties interested, if any;

"NOW, WHEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Parrilla;

"RESOLVED, as it is hereby resolved, to request the Public Service Commission, Manila, to transfer the place of hearing of the above mentioned application (Case No. 124129) from Manila to Ormoc City, and for this purpose, requesting further that the Municipal Judge of Ormoc City be authorized or commissioned to conduct and receive the evidence in hearing, in order to give a chance to interested parties residing in Ormoc to appear at the said hearing;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Secretary, Public Service Commission, Manila; the Applicant, c/o Atty. V. Sian Melkiza, 2626 Espiritu St., Singalong, Manila; Aboitiz and Co., Inc., Cebu City; and the Manager, Ormoc Electric Co., Ormoc City;

"CARRIED, Unanimously."
