RESOLUTION NO. 85

"WHEREAS, in a letter to this Board of even date, the Chief of Police, this City, informed that as of April 30, 1959, the appropriation for gasoline allowance of the two police jeeps has already a red balance of ₱251.39, and informing further that because of this red balance his requisition for gasoline was disapproved;

"WHEREAS, in the same letter the Chief of Police requested an appropriation of ₱500.00 a part of which will be used to offset the red balance and the remaining amount to be used by the two jeeps up to June 30, 1959 for gasoline and oil consumption; and

"WHEREAS, this Board finds that the request of the Police Chief is justified in order to maintain in readiness the said police transportation facilities in case of emergency and to facilitate immediate solution of crimes brought before the police department;

"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to appropriate the sum of ₱500.00 from out of any funds existing in the city treasury not otherwise appropriated, to be incorporated in the Gasoline and oil allowance of the two police jeeps, ₱251.39 of which will be used to offset the red balance as of April 30, 1959, and the balance to be utilized for the months of May and June, 1959;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor and the Chief of Police, all of Ormoc City.

"CARRIED, Unanimously."


