## RESOLUTION NO. 85

WHEREAS, in a letter to this Roard of ever date, the Chief of Police, this City, informed that as of April 30, 1959, the appropriation for gasoline allowance of the two police jeeps has already a read balance of P251.33, and informing further that because of this red balance his requisition for gasoline was disapproved;

"WHEREAS, in the same letter the Chief of Police requested an appropriation of P500.00 a part of which will be used to offset the red balance and the remaining amount to be used by the two jeeps to June 30, 1957 for gasoline and oil consumption; and

WHEREAL, this Not finds that the request of the Police Chief is is lifted in or to maintain in readiness the said police transportation facilities in case of emergency and to facilitate immediate solution of crimes brought Before the police department;

"MW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Gutierrez;

\*RESOLVED, as it is hereby resolved, to appropriate the sum of 2500.00 from out of any funds existing in the city treasury not otherwise appropriated, to be incorporated in the Gasoline and oil allowance of the two police jeeps, \$251.39 of which will be used to offset the red balance as of April 30, 1959, and the balance to be utilized for the months of May and June, 1959;

\*RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor and the Chief of Police, all of Ormoc City.
