RESOLUTION NO. 88

"WHEREAS, as per records of the last election the barrios of Domonar, Nasunogan and Nueva Vista have each registered more than 200 voters, but there are no electoral precincts in these barrios;

"WHEREAS, because of the distance of these barrios to their respective voting places, the electors residing thereat would have or encounter a lot of inconvenience, especially during rainy days; and

"WHEREAS, for many years now, the electors of these barrios have been requesting that electoral precincts be created or established in their respective barrios;

"NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilors Parrilla and Ocubillo;

"RESOLVED, as it is hereby resolved, to request the Commission on Elections, Manila, through the City Treasurer, Ormoc City, to create or establish electoral precincts each in the barrios of Domonar, Nasunogan and Nueva Vista, all of this City, which during the last elections registered more than 200 voters each;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Commission on Elections, Manila; the City Treasurer, Ormoc City; the Barrio Lieutenant, Domonar; the Barrio Lieutenant, Nasunogan; and the Barrio Lieutenant, Nueva Vista, all of Ormoc City.

"CARRIED, Unanimously."


