RESOLUTION NO. 96

"WHEREAS, during the widening of city streets the city used and occupied the whole of Lot No. 568 covered under TCT 2999 issued in the name of Teodora Varonda Vda. de Tomada, with an area of 16 square meters located along Rizal St;

"WHEREAS, the appraisal committee, this City, appraised the above mentioned lot at ₱30.00 per square meter as per an unnumbered resolution dated June 4, 1959;

"WHEREAS, the owners of the lot above mentioned are now claiming payment for the lot and for which this Body feels it an obligation of the city to them to compensate for their property used by the city for road purposes;

"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to approve the road right-of-way claim of Teodora Varonda Vda. de Tomada, hereby authorizing the payment for said claim, the amount of ₱480.00 to be taken as soon as funds are made available for the purpose, or at the rate of ₱30 per sq.m.;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, the City Engineer and Mrs. Teodora Varonda Vda. de Tomada, c/o Atty. Federico Pasana, all of Ormoc City.

"CARRIED Unanimously."


